4. Amendments to Chapter 16 (Nuisances) of the city code: Mr. Morris presented changes to Chapter 16 of the city code. The Committee reviewed the change in each section. Councilor Stubbs made a motion for approval for a public hearing and to approve the ordinance revising Chapter 16-8 of city code, and send to City Council after review by the Legal Committee to include in 16-8 'incurred by the city', section 16-8 'the income to go to code enforcement and 16-36 to remove number 1. Councilor Sanchez was the second. A voice vote of 3 to 1 with Councilor Moore voting no. The motion passed with Councilor Moore participating via GoToMeeting.
