

ORDINANCE NO. 463

AN ORDINANCE LEVYING GENERAL AND SPECIAL
TAXES FOR THE FISCAL YEAR 1927 AND 1928.

Be it ordained by the City Council of the City of Roswell:

Section 1. That there is hereby levied upon all property, real, personal and mixed, situate in the corporate limits of the City of Roswell, New Mexico, which is subject to taxation for State and County purposes, a tax for general city purposes of 5 mills on each and every dollar of the assessed value of said property in said City.

Section 2. That there is hereby levied on all property, real, personal and mixed, situate within the corporate limits of the City of Roswell, New Mexico, subject to taxation for State and County purposes, for the purpose of creating a bond sinking fund as required by law, at this time, for the redemption of the several and various bonds issued by said City of Roswell as the same may become due, a special tax of 7 mills upon each and every dollar of the assessed value of said property in said City.

Section 3 That there is hereby levied on all property, real, personal and mixed, situate within the corporate limits of the City of Roswell, subject to taxation for State and County purposes, for the purpose of paying the interest on the several and various bonds issued by the City of Roswell, as the same may become due, a special tax of 3 mills upon each and every dollar of the assessed value of said property in said City.

Section 4. That there is hereby levied upon all property, real, personal and mixed, situate within the corporate limits of the City of Roswell, New Mexico, which are subject to taxation for State and County purposes, for the purpose of paving in said City of Roswell, a special tax of one mills upon each and every dollar of the assessed value of said property in said City.

~~Section 5 That there is hereby levied upon all property, real, personal and mixed, situate within the corporate limits of the City of Roswell, New Mexico, which are subject to taxation for State and County purposes, for the purpose of providing and maintaining~~

~~parks by said City of Roswell, a special tax of _____ mills upon each and every dollar of the assessed value of said property in said City.~~

Section ~~6~~ ⁶ That said general and special levies of taxes are for the purpose of meeting and paying the expenses, current and otherwise, of said City of Roswell, for and during the fiscal years of 1927 and 1928, and the same are to be placed on the tax roll of Chaves County, New Mexico, for the year 1927, as provided by law.

Section ~~6~~ ⁶. That all ordinances and parts of ordinances in conflict herewith are hereby repealed.

Section ~~9~~ ⁹. This ordinance shall take effect and be in force after five days from and after its publication, and the City Clerk of the City of Roswell is hereby directed to deliver a certified copy of this ordinance to the Board of County Commissioners of Chaves County, New Mexico, on or before the 1st Monday in September 1927, so that said taxes so levied shall be placed on the tax roll of Chaves County, New Mexico, for the year 1927.
