

ORDINANCE NO. 1101

AN ORDINANCE PROVIDING FOR CORRECTIONS FEES TO BE COLLECTED FROM PERSONS CONVICTED OF VIOLATING ANY ORDINANCE RELATING TO THE OPERATION OF A MOTOR VEHICLE; CREATING A SPECIAL FUND; DETERMINING EXPENDITURE OF SAID CORRECTIONS FEES; AND REPEALING ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT THEREOF.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF ROSWELL, NEW MEXICO:

Section 1. Any person convicted of violating any ordinance relating to the operation of a motor vehicle shall pay a five dollar (\$5.00) corrections fee to the municipal judge who shall collect such fees as court costs.

Section 2. All corrections fees collected pursuant to this ordinance shall be deposited in a special fund in the municipal treasury and shall be used solely for the purpose of constructing, operating or maintaining the municipal jail or for paying the cost of housing municipal prisoners in the county jail.

Section 3. Severability. If any section, subsection, clause, phrase or portion of this ordinance is for any reason held invalid or unconstitutional by any court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision and such holding shall not affect the validity of the remaining portions of this ordinance.

Section 4. All ordinances and parts of ordinances in conflict with the provisions of this ordinance are hereby repealed.


Section 5. This ordinance shall be in full force and effect from and after its passage and publication as provided by law.
