

RESOLUTION 1986

BE IT RESOLVED BY THE GOVERNING BODY OF THE CITY OF ROSWELL that:

A. A regular municipal election for the election of municipal offices shall be held on March 4, 1986.

B. At the regular municipal election, persons shall be elected to fill the following elective offices:

1. One Mayor for a four year term.
2. One Councilor from each Ward for a four year term.
3. One Municipal Judge for a four year term.

C. The following precincts are consolidated for the regular municipal election within each Ward:

1. Ward I
 - a. 6, 14, and the portion of 13 lying east of Montana
 - b. 15, 41, 42, and 43
2. Ward II
 - a. 1, 2, 3, 4, 5, and 7
 - b. 10, 11, 12, and the portion of 13 lying west of Montana
 - c. 21 and 22
3. Ward III
 - a. 23, 24, and 25
 - b. 31, 35, and 36
 - c. 32, 33, and 83
4. Ward IV
 - a. 72, 81, 82, 84, and 85
 - b. 91, 92, and 93
5. Ward V
 - a. 51 and 52
 - b. 34, 61, 62, and 63

D. The following locations are designated as polling places for the conduct of the regular municipal elections:

1. Ward I
 - a. Voters in consolidated precincts 6, 14, and the portion of 13 lying east of Montana shall vote at Salvation Army Chapel, 612 W. College.
 - b. Voters in consolidated precincts 15, 41, 42, and 43 shall vote at Edgewood School, 701 N. Garden
2. Ward II
 - a. Voters in consolidated precincts 1, 2, 3, 4, 5, and 7 shall vote at Fire Station #3, 2911 N. Garden.
 - b. Voters in consolidated precincts 10, 11, 12, and the portion of 13 lying west of Montana shall vote at Military Heights School, 1900 N. Michigan.
 - c. Voters in consolidated precincts 21 and 22 shall vote at Washington Avenue School, 408 N. Washington.

3. Ward III
 - a. Voters in consolidated precincts 23, 24, and 25 shall vote at Y.M.C.A., Sunset and West Alameda.
 - b. Voters in consolidated precincts 31, 35, and 36 shall vote at El Capitan School, 2807 W. Bland.
 - c. Voters in consolidated precincts 32, 33, and 83 shall vote at Central Fire Station, Walnut and Richardson.
4. Ward IV
 - a. Voters in consolidated precincts 72, 81, 82, 84, and 85 shall vote at South Main Church of Christ, South Main and Buena Vista.
 - b. Voters in consolidated precincts 91, 92, and 93 shall vote at Fire Station #5, Gayle and Washington.
5. Ward V
 - a. Voters in consolidated precincts 51 and 52 shall vote at City Water Plant, 301 E. Alameda.
 - b. Voters in consolidated precincts 34, 61, 62, and 63 shall vote at Roswell Girls' Club, 503 E. McGaffey.

E. Voters in the absent voter precinct shall vote at the Office of the City Clerk.

F. Persons desiring to register to vote at the regular municipal election must register with the County Clerk of Chaves County not later than Tuesday, January 21, 1986, at 5:00 P. M., the date on which the County Clerk will close registration books.

G. All Declarations of Candidacy shall be filed with the Municipal Clerk on Tuesday, January 7, 1986, between the hours of 8:00 A. M. and 5:00 P. M.

H. The casting of votes by the qualified municipal electors shall be recorded on voting machines.
