

RESOLUTION NO. 2026

A RESOLUTION INSTRUCTING THE CITY ENGINEER TO GIVE NOTICE OF ASSESSMENT ROLL HEARING FOR THE WEST COUNTRY CLUB ROAD PAVING DISTRICT NO. 1985-2 FROM MAIN STREET TO MONTANA AVENUE.

WHEREAS, the City Council of Roswell, New Mexico, has by Resolution No. 1955 directed the City Engineer to prepare an Assessment Plat, Preliminary Plans and Estimates of Cost for the West Country Club Road Paving District No. 1985-2, and

WHEREAS, the City Council of Roswell, New Mexico, has by Resolution No. 1979 accepted the Assessment Plat, Preliminary Plans and Estimates of Cost for the West Country Club Road Paving District No. 1985-2, and

WHEREAS, the City Council of Roswell, New Mexico, has awarded the Contract for the Improvements to West Country Club Road, and

WHEREAS, said Improvements have been completed and the total cost of the Improvements to West Country Club Road have been determined, and

WHEREAS, the City Engineer has prepared and filed in the office of the Municipal Clerk of the City of Roswell, New Mexico, the final Assessment Plat and Roll for the West Country Club Road Paving District No. 1985-2 in accordance with Article 3-33-21 NMSA 1978,

NOW, THEREFORE, BE IT RESOLVED BY THE CITY OF ROSWELL, NEW MEXICO, that:

1.) The City Engineer is hereby directed to give notice of a hearing on the Assessment Roll for West Country Club Road Paving District No. 1985-2 at the regular City Council meeting of March 10, 1987. The notice of hearing on the Assessment Roll shall describe the improvement and the general location thereof, and state that any interested person may ascertain in the office of the City Clerk a description of the property to be assessed and the maximum amount of benefit estimated to be conferred on each tract or parcel of land. The notice shall comply with all requirements of Article 3-33-21 NMSA 1978.


2.) The foregoing notice shall also express the intent of the City Council of Roswell, New Mexico, to establish by ordinance the assessment for each tract or parcel of land in the West Country Club Road Paving District No. 1985-2 and provide for a maximum three (3) year deferred payment plan plus interest which shall commence thirty (30) days from the date of publication of the ordinance ratifying the assessment.


